### 1. Puppy Information

### 2. Deposit Terms

- A **non-refundable deposit** reserves a puppy.
- Puppies are chosen in the order deposits are received.
- Deposit may be transferred to a future litter once (1 time only).

### 3. Breeder Responsibilities

The Breeder guarantees:

- Puppy is healthy at time of pickup
- Puppy has first veterinary exam, first vaccine, and deworming
- Puppy has been raised in a  **kennel-free home environment**
- Puppy receives early socialization (children, household sounds, handling)

The Breeder will provide at pickup:

- Veterinary health record
- Feeding instructions + small starter bag of food
- Blanket or toy with litter scent
- AKC limited registration

## 4. Buyer Responsibilities

The Buyer agrees to:

- Have the puppy examined by a licensed veterinarian **within 72 hours**
- Provide regular vet care, vaccines, and heartworm prevention
- Never surrender the dog to a shelter — **Breeder will always accept the dog back**

## 5. Health Guarantee

The Breeder provides:

**A 24-month genetic health guarantee** against:

- Hip dysplasia requiring surgery
- Elbow dysplasia requiring surgery
- Congenital heart disease
- Life-altering hereditary diseases (confirmed by veterinarian)

In the event of a qualified hereditary defect:

- Buyer may receive **replacement puppy from next available litter**
- No refund of purchase price

## 6. Spay/Neuter Agreement (Pet Homes)

Buyer agrees this puppy is sold as a **companion pet**, not for breeding.

Buyer agrees to spay/neuter between **12–24 months of age**.

## 7. Return / Rehoming

If at any time Buyer cannot keep puppy/dog:

Buyer **must** return the dog to the Breeder.  
No refund provided.

We do not allow our dogs to be placed in shelters, rescues, or with unknown individuals.

## **8. Entire Agreement**

This agreement is binding upon both parties.
